

PAROLE AGREEMENT

TO ALL TO WHOM THESE PRESENTS MAY COME:

ROBERT L. WASHINGTON (WORK RELEASE) no. 102461

has been granted a parole by the Iowa Board of Parole subject to the following terms and conditions as set out by the Board of Parole and the Bureau of Adult Correction Services, to-wit:

1. I will proceed at once to my parole destination, enter into the parole plan which has been approved for me and will report to my Parole Officer as indicated below, in accordance with written instructions.

2. I am paroled to Henry County, State of Iowa, which is my restricted territory.
2b. I understand I will be under parole supervision a minimum of two years.
3. I will secure the permission of my Parole Officer before:
- Changing employment or residence.
 - Borrowing money, going into debt, or buying on credit.
 - Purchasing or operating a motor vehicle which shall be adequately covered by liability insurance.
 - Traveling outside my restricted territory within the State of Iowa.
4. I will, through my Parole Officer, secure the written permission of the Chief Parole Officer before:
- Opening or using a checking account in any bank.
 - Marriage.
 - Traveling outside the State of Iowa for any reason.
5. I will contact my Parole Officer at least once a month to submit a full, truthful, written report of my activities, on the form provided and will report at such other times as the Parole Officer may direct.
6. I agree to:
- Conduct myself honestly, not associate with or contact persons with criminal records, nor attempt to visit or correspond with persons in any jail or correctional institution. **unless approved by my parole officer.**
 - Keep reasonable hours and avoid taverns and other places of questionable reputation.
 - Support my dependents to the best of my ability.
7. I will obey all State and Federal laws, all local and municipal ordinances, and all traffic and motor vehicle regulations.
8. I will not own, possess, carry or use a firearm or weapon of any kind.
9. I agree to:
- Completely abstain from the use of drugs and narcotics, except as may be prescribed by a licensed physician.
 - Completely abstain from ~~(drinking)~~ the use of alcoholic beverages.
 - Attend AA meetings as instructed by the Board of Parole or my Parole Officer.
10. I expressly agree and consent that should I leave the State of Iowa and be arrested in another state, that I do hereby waive extradition to the State of Iowa from any state in which I may be found, and also agree that I will not contest any effort by any jurisdiction to return me to the State of Iowa.
11. I understand that I am under the supervision of the Bureau of Adult Correction Services and that my parole may be revoked for violation of any of the above conditions or for any reason deemed to be sufficient to the Board of Parole.

I hereby certify that I have read (had read to me) the above agreement, and that I do understand and agree that it shall be in full force and effect until I receive my final discharge from the Board of Parole. I certify that I have received a copy of this Parole Certificate and Agreement.
